Cane berries (Blackberry, Loganberry, Red and Black Raspberry, and Cultivars, Varieties and/or Hybrids of These)	Aphids, thrips, spotted wing drosophila	Foliar in a minimum of 20 gallons of water per acre	2-3 pounds per acre	Apply Grandevo WDG in a minimum of 20 gallons of water per acre using an electrostatic sprayer designed for low volume application.
